- For a pass, a candidate is required to obtain at least 30% marks in each Theory paper and Practical separately.
  - Classification : First division 60% or 1590 marks  
Second division 50% or 1325 marks  
Pass Class 40% or 1060 marks
  - A candidate failing in one theory paper only at the B.Sc. Ag. (Hons.) Pt. IV Exam. but obtaining not less than 30% marks in that theory paper and 40% marks in the aggregate of the whole examination (theory and practical) i.e. 260 marks, shall be eligible to appear at the Supplementary Examination also, with due papers of Part I, II, III Examination.
  - A candidate, who clears a paper in more than one attempt, shall be deemed to have secured the minimum pass marks only (prescribed for the paper irrespective of the marks actually obtained by him) for the purpose of determining his division at the B.Sc. Ag. (Hons.) Part IV Examination and also for the purpose of admission to the higher course of Study.
  - A circle drawn around the marks obtained in the subject denotes failure in that subject.
  - If any error in the result or the Marks-sheet is detected after declaration the result or the issue of Marks-sheet, the University will be fully empowered to correct the same.
  - Candidates desiring revaluation/rectification of their answer-books/result should apply on the prescribed application form so as to reach the Registrar, within 30 days from the date of the declaration of the result. Applications received after the due date shall NOT be entertained in any case.
  - All Court Cases shall be Subject to the Jurisdiction of the Rajasthan University Head Quarter i. e. Jaipur and not at any other place.
